

Ministerium FAQ

WHAT IS THE COVENANT MINISTERIUM?

The Covenant Ministerium is the collegium or community of all Covenant clergy and consecrated missionaries.

HOW DO I KNOW IF I'M A MEMBER?

If you hold any kind of Covenant ministerial credential, you are automatically a member of the Covenant Ministerium.

WHAT ARE MY MEMBERSHIP OBLIGATIONS?

The constitution of the Covenant Ministerium states that you are required to maintain good standing in a regional ministerial association. These are associations organized on the conference level. Among other things they are responsible for retreats, clusters/districts, and continuing education opportunities. The elements of good standing include:

- Up-to-date payment of **annual dues** to the treasurer of the conference in which the minister serves. Status can be checked by contacting your conference ministerium treasurer. Military Chaplains should contact the Ministerium's Executive Committee treasurer; missionaries should contact Serve Globally. The amount is set by the conference ministerial association so they are different in each conference. However, \$85 of that amount is forwarded by the conference association treasurer to the treasurer of the Covenant Ministerium.
- A **current profile** on CovConnect. The profile should be updated every 3 years in order to qualify as "current." CovConnect is administered by Ordered Ministry, and that staff can answer questions regarding access.
- The **Vocational Growth Tool** (VGT) was formerly known as the Continuing Education Report. Completion is now electronic. The VGT is found under the resources tab once you have signed in to CovConnect. It must be completed annually.
- **Regular healthy connections** with your ECC ministerial colleagues can be achieved in a number of creative ways from attendance at retreats and Midwinter to regular phone or Skype conversations.

ARE DUES MANDATORY OR "SUGGESTED"?

The dues are mandatory. Failure to pay dues can eventually result in the loss or suspension of ministerial credentials.

DOES EVERYONE HAVE TO PAY DUES?

No. Those who are on inactive or retired status are exempt from paying dues.

IS THERE ANY OTHER WAY TO GET AN EXEMPTION?

Yes. If you are experiencing financial difficulty you can write to the president of the Covenant Ministerium. S/he has been authorized by the executive committee to grant exemptions. You should also write to the president of your regional conference ministerial association, who can grant an exemption for the conference portion of your dues.

WHAT ABOUT MISSIONARIES & MILITARY CHAPLAINS?

Consecrated missionaries and chaplains are full members of the Ministerium and like their colleagues pay dues in order to maintain standing. However, the Rules for the Ordered Ministry state that “Military chaplains and consecrated missionaries shall maintain their standing through the office of the executive minister of the ordered ministry...” (Art. XI. Sec. 11.2.c) We are currently interpreting this to mean that missionaries and chaplains will pay only the \$85 portion of the dues that goes toward the Ministerium and they pay that directly to “The Covenant Ministerium” c/o the Ordered Ministry, 8303 W. Higgins, Chicago, IL 60631 USA.

WHEN ARE DUES DUE?

Different conference associations have different ways of collecting dues. Generally speaking, however, dues are expected to be paid by May 1st of each year. For example, dues for the May 1, 2018 - April 30, 2019 fiscal year are due on May 1, 2018.

WHAT IF I MOVE TO A DIFFERENT CONFERENCE, WHICH ONE DO I PAY?

Pay dues to the conference ministerial association to which you belong on April 1. For example, if you are serving a church in Illinois on April 1, 2018 but move to a church in California on April 15, 2018, you would still pay your dues for the 2018-2019 year to the Central Conference Ministerial Association (even though you were not technically residing there on the first day of the fiscal year). But in the following year you would pay to the Pacific Southwest Conference association.

WHAT HAPPENS TO THE DUES MONEY?

Each year the annual meeting of the Covenant Ministerium is held just prior to the annual meeting of the ECC. One thing that happens at that meeting is the adoption of a budget. If you missed the annual meeting, you can still see the budget, along with the minutes of the meeting, in the Covenant Yearbook for this year.

DO I HAVE TO GO TO THE ANNUAL MEETING OF THE MINISTERIUM OR SEND A LETTER IF I DON'T GO?

No one is keeping attendance. But it is one of several ways that we carry out our common business, worship together, and participate in continuing education that relates not just to the needs of the individual but the group as a whole. A greeting from those who must be absent may be sent to the secretary of the Ministerium as an optional courtesy.

DOES THE MINISTERIUM HAVE ANYTHING TO DO WITH THE PENSION AND HEALTH INSURANCE?

No, not directly. The Covenant pension plan and the Covenant insurance program are both overseen by the Covenant Benefit Board. See <http://www.covchurch.org/benefits/pension/> for more info.

WHAT IS THE CONTINUING EDUCATION REQUIREMENT?

Several years ago, the Ministerium created a continuing education requirement for its members in an attempt to encourage ongoing professional development. Ministers and missionaries are expected to have four vocational growth experiences per year and to report those experiences on an annual form that goes to the Ordered Ministry. This requirement was redesigned and implemented in 2012. The form is called the Vocational Growth Tool and is sent out via email from Ordered Ministry around January of every year. It is available through CovConnect.

WHAT'S THE DIFFERENCE BETWEEN THE MINISTERIUM, THE BOARD OF THE ORDERED MINISTRY, AND THE ORDERED MINISTRY TEAM?
