Minutes of the Annual Meeting of the Covenant Ministerium

Minneapolis, Minnesota June 21, 2018 1 p.m.–5 p.m.

CALL TO ORDER

Catherine Gilliard, president, called the meeting to order.

PRAYER

Robert Johnson, vice-president, prayed.

ORGANIZATION OF THE MEETING

Adoption of Standing Rules. Parliamentarian Steve Bilynskyj moved the adoption of the standing rules. The motion was seconded and approved.

Aproval of Agenda, including Consent Agenda Items. Amanda Olson requested a motion called "Pathway to Unity" be added to the agenda. The motion instructs the Board of the Ordered Ministry to form a task force of Covenant clergy charged to care for the unity of the church in regard to our position toward and relationship with LGBTQ congregants. The request was sent by President Gilliard to the Board of the Ordered Ministry for consideration. Steve Bilynskyj explained that this ruling is the appropriate path for such motions according to the bylaws. Greg Applequist was recognized by the chair to report on the work currently being done on the Board. Doug Bixby challenged the motion being deferred. The referral stood due to Ministerium procedure. The president read the motion. "Pathway to Unity" was referred to the Board.

The agenda as presented was approved.

Amend Section 3.1, which now reads:

Section 3.1. Membership in the Covenant Ministerium is defined in the Constitution and Bylaws of the Evangelical Covenant Church. All members shall maintain good standing in a regional ministerial association. Good standing within the Covenant Ministerium includes annual dues, a current profile, annual completion of a vocational growth tool and regular healthy connections with ministerial colleagues. Licensed theological students, ministers and missionaries in the inactive category, and ministers serving ECC congregations without ECC credentials shall be associate members without voting privileges or the holding of office in the Covenant Ministerium.

by removing "Licensed theological students" in the last sentence, so as to read:

Ministers and missionaries in the inactive category, and ministers serving ECC congregations without ECC credentials shall be associate members without voting privileges or the holding of office in the Covenant Ministerium.

Rationale: The LTS category is no longer offered.

APPROVAL OF PROPOSED 2017 REVISIONS TO

CONSTITUTION AND BYLAWS

The revisions to the Ministerium Constitution and Bylaws presented in 2016 for vote in 2017, presented for vote at this meeting were approved.

CENTRO HISPANO ESTUDIOS TEOLOGICOS (CHET)

Ed Delgado, president of CHET brought greetings and referred the Ministerium to his written report on the website (contained in the Annual Report of the ECC).

NORTH PARK THEOLOGICAL SEMINARY

David Kersten, dean, spoke of the Covenant Scholars Program designed to ease finances for students. There are ten students this year. The seminary hopes to make this scholarship program the primary means of financial aid.

A much needed rehab of Nyvall Hall is planned, including the kitchen, chapel, air conditioning, bathrooms, and, hopefully, an elevator to all levels.

NPTS is celebrating Carl Balsam who has been helpful to the seminary in his role as interim president of NPU.

West Coast Ignite has forty-three students who are serving in ministry while going to school at a 50 percent tuition discount. They would like to do Ignite East Coast.

Stateville Cohort—seminary classes at Stateville Correctional Center—will launch this fall with forty students. Students will earn an MA degree and serve as peer mentors in prison.

New teaching fellows at the seminary include Armida Belmonte Stephens (theology), J. Nathan Clayton (Old Testament), and Michael Walker (theology with focus on disability ministries).

NORTH PARK UNIVERSITY

Carl Balsam, interim president, introduced Mary Karsten Surridge, current vice-president of advancement, as the nominee for president of NPU. Balsam said that Surridge has been a friend to NPU for over twenty years and has contributed to its success. Surridge knows the landscape of Christian higher education and higher education in general. She has a passion for both NPU and NPTS and is a person of great faith and humility.

Surridge said she is grateful for the legacy of the Covenant Church and North Park, which is a compass for the future. Her vision is for NPU to be the institution of discovery and high academic quality in a world-class city, stressing a life of faith and a daily walk with Jesus, remaining a strong, vibrant, and relevant Christian university. She operates from relational and historic strength with the ECC and aims to work collaboratively with the denomination.

NOMINEE FOR EXECUTIVE MINISTER OF DEVELOP LEADERS ORDERED MINISTRY

- a. Report and Nomination from the Board of the Ordered Ministry. Mark Pattie, chair of the nominating committee, reviewed the search and approval process. From thirty nominations, including a diversity of ethnicity and gender, five candidates were asked to write statements. Pattie described the nominee, Lance Davis, as "collegial, a team-builder, relational, a learner, comfortable with success and failure, and a man of deep, daily spiritual practices." Davis, he said, emphasized being present with one another as a way to growth and discernment. He makes significant decisions openly, working with a team. He believes in and loves the ECC, our heritage, the church we are, and the church we are becoming.
- b. **Nominee Statement**. Davis spoke of and thanked four influential women in his life: his wife, Kara Davis; his mother, Phyllis Davis (a recent NPTS grad), his cousin Debbie Griffith Samuels; and his sister Leslie. Thanking the nomi-

nating committee, he recognized others who were nominated for the position. He spoke of his experience in preaching, being a pastor among pastors. He told about his organization for clean water in Ghana that is now starting a church. Davis's church in Dolton, Illinois, is in a building that was used for drugs. The food pantry he started now feeds more than 140,000 people. He started a robotics program that has helped kids go on to education. Davis wants to build competency and compassion among clergy and to develop training for lay leaders. He is committed to getting to know each of us, build relationship with pastors in all areas. He believes he is called to this role "for such a time as this."

- c. **Discussion.** Paul Corner asked about the way forward in the LGBTQ discussion. Davis acknowledged the pain of being marginalized, while upholding the ECC position. He said he would always listen and embrace. Aaron Johnson asked about the relationship between Scripture versus freedom. Davis said our freedom within Christ has boundaries, but the freedom is the ability to live freely in Christ. He related that to inner peace that allows us to handle issues peacefully. Tyler Mennsen asked about resourcing ethnic communities that they might become more involved in the ECC, conference, meetings, etc. Davis said that though we have come a long way, we need new ways to help us attend meetings, citing technology as a road to explore. Jeff Hunter gave a word of testimony for Davis in his work in a class in prison ministry the pastor attended. Doug Bixby asked about Davis's reflections on how a better ecclesiology might help us move forward in discussions on sexuality. Davis said he thinks the resources coming forth are helpful. We are talking about human beings.
- d. **Vote of Concurrence.** Ministerium voted on whether to affirm the nomination of Lance Davis.

ECC PRESIDENT'S REPORT

Gary Walter's final report as president began by reminding us that God knows our names, something Gary learned as a young man in a Covenant church. He then reported the following highlights.

We are touching more people than at any time in our history.

We find a relational home in the ECC. When Jesus had something hard to say to the rich young ruler. "Jesus looked at him, loved him, and said to him" a hard truth. We can't say hard truths without love.

The Covenant Executive Board has commissioned a new resource paper on freedom and responsibility. A team will be nominated and put together by the Executive Board, followed by a scope team, a broader group. Then there will be opportunities for everyone to comment. It will be an open process. A writing team will submit their work to the Board of Ordered Ministry, redraft, submit to the Council of Administrators, Council of Superintendents, back to Board of the Ordered Ministry, and so forth.

Gary asked our Hispanic brothers and sisters to stand. He acknowledged the pain of recent days with the separation of children at the border. "Your lives matter." When you are under-resourced, you are underrepresented, he said.

Gary reported that the church had needed a chief ministry office, and so he hired Dick Lucco as executive director for ministry development. Gary expressed praise for and thanks to Dick.

In concluding his report, Gary said, "Fare thee well as you go deeper in Christ and further in mission." He received a standing ovation.

INTERIM EXECUTIVE MINISTER'S REPORT

Dick Lucco offered thanks to many people, including the Ministerium, for serving often in tough places, to the many who have been praying for him and for those who have not been happy with him, for the many clergy getting their credentials in order to be able to vote at this meeting, the Develop Leaders staff, to the Board for Ordered Ministry in this difficult year, and to Catherine Gilliard, for creating space for conversations—conversations we should be having in our

churches, retreats, and conferences. Dick said it has been an honor to serve the church, and, he said, his service among us for forty plus years has formed him. We have just sent in a Lilly Grant proposal for \$1,000,000 on resilience in ministry. "Take care of yourself—body, mind, and spirit," he said.

Dick quoted a Tibetan proverb: "The secret to a long life is to eat half, walk double, laugh triple, and love without measure" He said he has added, "pray constantly" and admonished us from Romans 12:9ff. "Be devoted to one another in love. Honor one another above yourselves." He quoted Heather Larson, executive pastor at Willow Creek, who started shortly before the blowup there: "I choose to be here. I choose to keep showing up. I choose to put one foot in front of the others. I choose to have hope there is way though this storm. I choose to live God will redeem this situation in ways we never could ever imagine.

A presentation was made to Dick Lucco citing his extraordinary service. The Ministerium gave a monetary gift in partnership with the denomination to Dick and his wife, Val, for a much-needed vacation.

INTRODUCTION OF ECC PRESIDENTIAL NOMINEE

Catherine Gilliard introduced John Wenrich, nominee for president of the ECC.

Wenrich said there are three things we should know about him. "One, I follow God as best I can relying on the Holy Spirit." He wants to be known for how he follows, not just how he leads, leaving a legacy of "followership." A conscious dependence on the Holy Spirit is a deep and life-sustaining commitment for him. He has tried to guard his heart against presumption. Two, he loves the ECC and our mosaic of Mission Friends. He felt he had found the pearl of great price when he came into the Covenant and still does. He called all of us—men, women, all ages, all of us—to rise to new challenges. Three, he said he leads out of spiritual brokenness. He is not a culture warrior, he is a Christ follower. He got into ministry not to win an argument but to lay down his life for the sake of the whole gospel; he entered ministry to make a difference, not a point.

A time of questioning the candidate followed. Jodi Mullen Fondell acknowledged that Wenrich is not a person of color or a woman and asked about hearing the voice of the LGBTQ community who are believers and want a voice. Wenrich said he feels we haven't had the conversation on sexuality yet. In the ECC, we want to lead with love. These are our people, our sons and daughters. If the gospel is not good news for them, it is not good news for anybody. He said, you are made in the image of God if you are gay—you belong here. He is sorry for how some have been treated. "I love you. God loves you," he said. He pointed to Michelle Sanchez's work to develop resources that are compassionate. He has been spending a lot of time reaching out to various groups and people about LGBTQ, he said. He cited the discerned position—we have taken vows as clergy to live and act within that.

Larry Kamphausen asked how he will, as president, lead by stepping back and allow the leading to come from the priesthood of all believers? Wenrich said he has been seeking to model that by meeting with various people to learn from them, including bringing them to Chicago. Leaders model how to learn, he said.

DIRECTIONAL CONSIDERATIONS FOR CLERGY PENSION PLAN

Paul Hawkinson, Covenant treasurer and executive director of finance, offered an abbreviated view of considered changes to the pension plan. Our defined benefits plan does not work for everyone, he said—people are living longer and we haven't changed the rate of pension. He did say, "ECC plan evaluations are from a position of strength. We have a quarter billion dollars in assets."

The guiding principles of the Board of Pension are:

- —Ensure highest quality retirement benefits for our pastorate.
- —Ensure long-term plan health, deliver 100 percent of benefits earned.
- —Optimize offerings to better match diverse service pathways.
- —Increase fairness and access for under-resourced settings.

- —Honestly evaluate risk, protect the church and its servants.
- —Listen well to a wide ECC constituency, seek expert advice.
- —Understand economic and other (ministerial) effects of change.
- —Alongside Lilly work, ensure that education is central.

The Pension Board hopes to make a presentation of the changes at the 2019 Annual Meeting with implementation by December 31, 2019. For the next twelve months the board will focus on what a new plan will look like. A new IT plan will be launched so that we will have access to our pension data. Changes will include:

- —Closure of defined benefit plan to new participants (December 2019)
- —Select amendments to the remaining plan
- -Optional buyouts offered to "inactive vested" participants
- —Optional election for active pastors to freeze current accrued benefit
- —New pastors (and new money for frozen accounts) enter a 403b(9)
- —Will remain mandatory at some material level (~10%) of church funding
- -Credential requirements under review
- -Match funding mechanism for under-resourced settings
- —Match funding sustained by Lilly/ECC/donors/resourced churches
- —Pensioners: no impact, while excess "gains" inure to benefits
- -Inactive vesteds: optional liquidity
- —Actives: optional freeze, creating a hybrid plan
- -Ministerium: two-plan environment for extended period
- —New pastors: compelling, long-term/portable 403b plan
- —Tailored education a central theme/Lilly integration

APPROVAL OF THE AGENDA, CONT'D

Steve Bilynksyj was asked to re-explain the ruling President Gilliard made on the "Pathway to Unity." He did so, citing Article 6, Section 1 of the ECC Ministerium Constitution and By-laws:

Section 6.1. Any matters arising in the Covenant Ministerium relating to the ordination, licensure, commissioning, consecration, and discipline of ministers and missionaries, and matters of policy or principle regarding the Rules of the Ordered Ministry or the work of the Board of the Ordered Ministry shall be referred to the Board of the Ordered Ministry for consideration and recommendation before action by the Covenant Ministerium.

SEASON OF PRAYER-GUIDED PRAYER BY MINISTERIAL COMMUNITY

Mary Peterson, president of ACCW, led in a time of remembering the pastors, missionaries, and clergy spouses who died in the past year. The names are listed in the minutes of the 133rd Annual Meeting of the ECC.

Looking back on the reports and discussion of the day, the following resolutions were entered:

Whereas we have been reminded that there is no mess like a church mess, therefore be it resolved that we will continue to move the dial through healthy conversations regarding sexuality, women in ministry, racial inclusion, and thriving in ministry.

Whereas we have learned about the impact of large abdominal circumferences, therefore be it resolved that we will make efforts to be healthy pastors—physically, mentally, emotionally, and spiritually.

Whereas we have new leaders in many levels of our denomination, therefore be it resolved that we will cover these women and men with prayer and may God lead them, guide them, and direct their steps as they follow you.

Minutes of the 133rd Annual Meeting of the Evangelical Covenant Church

Minneapolis Marriot City Center Minneapolis, Minnesota June 21-23, 2018

FIRST BUSINESS SESSION

Friday, June 22, 2018 8:39 a.m.

1. MORNING WORSHIP

Moderator Sam Chang called the business session of the 133rd Annual Meeting to order. Beth Severson, director of evangelism, and Michelle Sanchez, executive minister of make and deepen disciples, spoke during a time of worship.

2. OPENING STATEMENT BY THE MODERATOR

The moderator explained procedures, issued an opening statement, and introduced the officers and staff on the platform. Norma Ramos, manager of ministry services, announced in Spanish that supporting material for various agenda items were available in Spanish.

3. GREETING FROM NORTHWEST CONFERENCE

The moderator recognized Mark Stromberg, superintendent of the Northwest Conference, who greeted the assembly on behalf of the conference and its churches.

4a. REPORT ON CREDENTIALS AND MOTION

The moderator recognized Karen Figueroa, chair of the credentials committee, who presented the following motion: "Those persons who have currently been registered and certified as delegates with the committee on credentials together with those who shall subsequently be registered and certified in the course of this Annual Meeting shall constitute the official roster of the 133rd Annual Meeting of the Evangelical Covenant Church."

Figueroa then reported that registration as of Friday morning included 768 credentialed voting delegates and 292 additional registrants in various non-voting categories for a total registered conference attendance of 1,060.

The motion carried.

5. ACTION ON THE STANDING RULES

The moderator recognized Nancy Lewis, vice-moderator, who, on behalf of the agenda committee, moved the adoption of the standing rules as follows:

STANDING RULES OF ORDER 2018 COVENANT ANNUAL MEETING

1) Obtaining the Floor

Only persons wearing appropriate credentials as delegates, advisers, or resource persons may be present on the floor of the Annual Meeting or request speaking privileges. With the exception of points of order, points of personal privilege, or other items that require urgent attention, only those persons who approach a microphone shall be recognized by the moderator.

2) Voting

Voting on motions will typically be by voice vote. Any delegate may request voting by ballot on any particular question. This request, when supported by 10 percent of the delegates present and voting, will be implemented. The moderator may direct that voting be by ballot on any question.

3) Time Limits

- a) Reports that contain no proposal for action by the meeting shall be limited to ten (10) minutes, including the question period, with the exception of the president's report, the treasurer's report, and items specified in the agenda as longer reports.
- b) Debate on any main motion, including its subsidiary motions, shall be limited to thirty (30) minutes, except as otherwise specified in these standing rules and the agenda. No amendment or other subsidiary motion to a main motion shall be allowed until debate on the main motion has ceased or ten (10) minutes have passed.
- c) No speech in debate may exceed three (3) minutes unless this period is extended by a majority vote at the request of the speaker.
 - d) Time limits may be extended for a specific period by a two-thirds vote.

4) Submission of Motions in Writing

All main motions and complex subsidiary motions shall be submitted in writing to the secretary.

5) Items of Business Not on the Agenda

The Bylaws provide in Section 7.8.a.ii that "Items of business that are not on the agenda may be submitted in writing by a delegate to the moderator. If the item submitted is in order, a majority vote of the delegates present and voting shall be required to place that item on the agenda." It is further strongly requested that such items be submitted to the moderator as early as possible in the course of the meeting.

6) Consent Agenda

Items on the consent agenda are routine, procedural, informational, self-explanatory non-controversial items that require action but generally don't require discussion or debate. Acting on these items moves the meeting along, allowing for more time for substantive issues. Items on the consent agenda may be removed from the consent agenda at the request of any two delegates. Items removed from the consent agenda shall be acted upon by the assembly at a place in the agenda determined by the moderator. If the consent agenda is not adopted by the unanimous consent of the meeting, then each of the items on the consent agenda shall be acted upon by the assembly as a separate motion at a place in the agenda determined by the moderator.

7) Nominations from the Floor

A nomination from the floor shall be accepted only if the person nominated has agreed to have his or her name placed in nomination. (Note that the Bylaws provide in Section 7.9.c.v.2 and 7.10.j.ii that a delegate making a nomination may provide descriptive information similar in scope and content to that provided to the Annual Meeting by a nominating board or committee.)

8) Run-off Elections

In the case of an election with three or more candidates, if no candidate receives a

majority of votes after two rounds of voting, then beginning with the third round, the candidate with the lowest number of votes in that round will be eliminated. In the event of a tie among the lowest vote-getters, those tied will not be eliminated in that round. A candidate may withdraw at any point. Voting rounds will continue until one candidate receives a majority of votes.

8) Modification of Agenda Order

The moderator shall have the discretion to revise the order of agenda items to accommodate scheduling needs.

29. MISSION AND MINISTRY LEADERSHIP REPORT

Vice-moderator Nancy Lewis called the delegates attention to the annual report provided at registration. She invited delegates to submit in writing any questions they might have of administrators by the end of Friday's business session for responses from administrators during the Saturday afternoon session.

11. REPORT OF THE PRESIDENT

The moderator recognized Gary Walter, for his last report as president of the Evangelical Covenant Church. Referencing a number of items in his offfice, Walter spoke to significant elements in the ministry and life of the Covenant Church: roosters that call attention to God's actions in the world; coffee mug with the Covenant logo, reflecting that we are biblical, devotional, missional, and connectional); an Alaskan soup spoon that represents hospitality; World Vision book of photos of children who have access to fresh water through the support of CovKids Congo; piece of foundation from the first Covenant congregation, which was in Swede Bend, Iowa, signifying that we are the inheritors of a tradition.

Walter highlighted the mission and the structure of the Evangelical Covenant Church in a slide presentation. He encouraged all delegates to read the Annual Report for specifics, pointing out that we as the ECC are reaching more people in more places among more populations.

He identified three areas of concern. 1) Covenant cohesion: we have been highly relational, and new patterns of relationships are emerging. What are we doing to invest in cohesion of the Covenant? 2) Multi-ethnic kingdom mosaic: this is vitally important, and the ECC has made good progress, with one third of the church reflects diverse ethnicity. We need to be relational and intensional. Walter invited the Latino/a delegates to stand, and he said, "We stand with you—your lives matter." 3) Navigating human sexuality: affirming God's boundaries that are meant for our flourishing. Covenant churches have not done well in this sensitive area—we must grieve and grow, and we must love better, he said. We will find areas in which to move forward: three such areas are the common ground we share, resources for equipping pastors and churches, and the Board of the Ordered Ministry is engaging in learning more about human sexuality.

Walter announced that the Executive Board had commissioned a Covenant Resource Paper on Freedom and Responsibility.

Walter called the following individuals to speak to a particular focus: Michelle Sanchez, executive minister of make and deepen disciples, highlighted the Embrace webinars on human sexuality; Cecilia Williams, executive minister for love

mercy do justice, spoke on initiatives to reunite immigrant families, disaster relief, a legal service center, affordable housing, and racial righteousness; Adam Gustine, director of ministry initiatives, and Lance Davis, pastor of New Zion Covenant Church in Dolton, Illinois, spoke about Covenant Enterprises, which supports businesses that seek to impact barriers in communities.

Walter then introduced a second panel to talk about global ministries: the Rev. Jules Mboka, president of CEUM (Covenant Church in DR Congo), shared what amazing work God is doing in DR Congo; Al Tizon, executive minister of serve globally, spoke to the significant ministries of the Covenant Church in Congo and the recent developments there in public health and health care, education, and economic initiatives; and Gary Gaddini, pastor of Peninsula Covenant Church, reported that Global 6k included 80 churches, 4,000 runners, and raised \$340,000.

In closing, Walter spoke about two Covenant pastors and leaders who impacted him: Ray Dahlberg, secretary of world mission, whose life and service spoke to the fact that God's mission is in the hearts of his people and it passes from generation to generation; and Willie Jemison whose conversations with Walter always ended with a word of challenge: "You're doing good but, you know, you can do better." Walter concluded his report with the same challenge to the gathered Covenant Church, and closeed with: "Fare thee well as you go deeper in Christ and further in mission; fare thee well as you walk as obedient, humbled servants; fairly thee well, fare thee well, fare thee well because we know our Redeemer lives! Amen!"

The Worship Team played "My Redeemer Lives," and then Alice Lee, chair of the Executive Board, prayed for Walter and the ministry of the Evangelical Covenant Church.

14. CALL OF PRESIDENT OF NORTH PARK UNIVERSITY

The moderator recognized Owen Youngman, chair of the North Park University presidential nominating committee, who presented Mary Karsten Surridge as the nominee for president of North Park University. Surridge briefly addressed the delegates. The delegates voted to call Surridge as president of NPU. Darrell Griffin, member of the NPU Board of Trustees, prayed for her.

26. FISCAL YEAR 2017 FINANCIAL REPORT

The moderator recognized Paul Hawkinson, executive director of finance and treasurer of the Covenant, who reported on the consolidated operations and financial position for fiscal 2017. There was a base mission budget surplus of ~\$52,785. There was solid expense control, with actual expenses held at ~4.6 percent or \$769,555 below budget. Continued progress was made on improving net unrestricted mission reserves while managing consolidated debt. Continued strong enrollment, sound reserves, and good operating results for Bethany Benefit Service operations, which announced a 3 percent medical rate increase for 2018, bringing its three-year average trend medical rate increase to ~2.25 percent. The Pension Plan for fiscal 2017 had total net assets available for benefits of ~\$255.1 million, representing a ~105 percent funding level relative to its \$241.5 million projected actuarial liability for future benefits. "While no definitive plan is yet identified," Hawkinson said, "we continue an ongoing evaluation of the future form of the Covenant Pension."

Jon Bonkoski, chair of the Executive Board finance committee, prayed for Hawkinson and for God's provision and generosity of God's people.

12. ELECTION OF PRESIDENT OF EVANGELICAL COVENANT CHURCH

The moderator recognized Mary Miller, chair of the presidential nominating committee, who on behalf committee presented John Wenrich as the nominee for the tenth president of the Evangelical Covenant Church.

22. RECOGNITION OF CARL BALSAM, INTERIM PRESIDENT OF NORTH PARK UNIVERSITY.

Gary Walter presented Balsam with a citation, and Kristine Strand prayed for him.

27. PRESENTATION AND ADOPTION OF THE 2019 MISSION AND MINISTRY BUDGET

The moderator recognized Paul Hawkinson, executive director for finance and treasurer, who gave a presentation on the proposed mission and ministry budget for fiscal year 2019 and made the following motion: "COLT and the Executive Board recommends the fiscal year 2019 Mission and Ministry Budget in the amount of \$25,867,034 for adoption by the 2018 Covenant Annual Meeting."

34b. NORTH PARK UNIVERSITY CONSTITUTIONAL AMENDMENTS

The moderator recognized Rebecca Gonzalez, who on behalf the NPU Board of Trustees and in concurrence of the Executive Board, moved that the following amended constitution of North Park University be approved:

Amended and Restated Constitution of North Park University an Illinois Not for Profit Corporation

PREAMBLE

North Park University is affiliated with The Evangelical Covenant Church, and is organized exclusively for educational, religious, charitable, scientific, and literary purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provisions of a future United States Internal Revenue laws (hereinafter the "Code"), including for such purposes, the making of distributions for organizations that qualify as exempt organizations under Section 501(c)(3) of the Code. Consistent with these purposes, the University provides, in affiliation with The Evangelical Covenant Church, undergraduate and graduate education, including a theological seminary, that integrates Christian faith, learning, and service.

North Park University, in order to accomplish its mission and purposes, has formulated and adopted this Constitution and Bylaws. North Park University shall be governed by this Constitution and Bylaws, its Articles of Incorporation, and all applicable laws.

CONSTITUTION

ARTICLE I

Name and Incorporation

Section 1.1. The name of the corporation is North Park University (the "University"). The University is organized as a not-for-profit corporation under the laws of the State of Illinois.

ARTICLE II

Offices

Section 2.1. The location of the principal office of the University is in Chicago, Illinois. The University may have such other offices, either within or without the State of Illinois, as the Board of Trustees may determine or as the affairs of the University may require from time to time.

ARTICLE III

Member

Section 3.1. The University shall have one class of membership. The sole member of the University is The Evangelical Covenant Church, an Illinois not-for-profit corporation (hereinafter, "ECC"). The ECC shall have all of the rights provided to the University's member (i) under the University's Articles of Incorporation, and Constitution and Bylaws, (ii) under the ECC's Articles of Incorporation, and Constitution and Bylaws, and (iii) afforded to voting members of an Illinois not-for-profit corporation under the Illinois General Not for Profit Corporation Act to the extent such rights are not modified or superseded by the University's Articles of Incorporation, and Constitution and Bylaws, or the ECC's Articles of Incorporation, and Constitution and Bylaws. A convention of delegates representing member churches of the ECC known as the Annual Meeting is the highest constituted authority of the

ECC ("ECC Annual Meeting"). The Executive Board of the ECC ("ECC Board") is the agent of the ECC Annual Meeting in making decisions for, and otherwise acting on behalf of, the ECC when the Annual Meeting is not in session. Article III of the University's Bylaws entitled "Powers Reserved by the Member," as well as the Constitution and Bylaws of the ECC, specify powers reserved by the ECC as the sole member of the University, and set forth whether such powers are to be acted upon and approved by either the ECC Annual Meeting or the ECC Board.

ARTICLE IV

Board of Trustees

Section 4.1. The affairs of the University shall, subject to the reserved powers of the Member, be managed by a Board of Trustees as more fully set forth in the University's Bylaws.

ARTICLE V

Dissolution

Section 5.1. Dissolution of the University must be approved by the ECC Annual Meeting. The assets of the University shall, upon dissolution, be distributed as set forth in the Articles of Incorporation of the University.

ARTICLE VI

Amendments

Section 6.1. Proposed amendments to this Constitution shall be introduced in writing at an ECC Annual Meeting but cannot be acted upon until the next Annual Meeting.

Section 6.2. At least ninety days before the ECC Annual Meeting when final action is to be taken on a proposed amendment to the Constitution, the corporate secretary of the ECC shall send a copy of each proposed amendment to each ECC congregation and shall cause the text of each proposed amendment to be published in the official print publication of the ECC and/or in the electronic media the ECC regularly uses for communication with ECC congregations and members of the ECC congregations.

Section 6.3. A proposed amendment to this Constitution shall be adopted upon the affirmative vote of two-thirds of the delegates present and voting at the ECC Annual Meeting.

The motion to approve the NPU Constitution was passed.

35.c. REPORT FROM NORTH PARK THEOLOGICAL SEMINARY

The moderator recognized David Kersten, dean of North Park Theological Seminary, for his report. Highlights included expansion of distance education, launching the Ignite cohort, the development of the Stateville Correction Center seminary program, renovation of Nyvall Hall, and the launch of the Covenant Scholars program. Christine Rosell, member of the NPU Board of Trustees, prayed for North Park Theological Seminary and Dean Kersten.

28. REPORT FROM THE BOARD OF PENSION AND BENEFITS

The moderator recognized Paul Hawkinson, who gave a report on the current status and future considerations of the clergy pension plan. He said the recommendations for changes will be shared at the 2019 Annual Meeting to be put into place by December 2019. He said the Board of Pensions and Benefits anticipates the recommendations will include the following: a proposal to close the current defined benefit plan to new individuals; selected amendments will be offered to remaining participants; inactive participants will be offered optional buyouts; if a participant is in the plan, they may choose to remain or to freeze benefits and join with the new pastors in a new plan; all new pastors will roll into a new plan (the Board of Pensions and Benefits will always have a mandated plan); the potential to build large, match-funding program for under-resourced churches.

31. REPORT FROM COVENANT MINISTRIES OF BENEVOLENCE

The moderator recognized Roger Oxendale, president and CEO of Covenant Ministries of Benevolence, who reported that CMB has 7,000 employees, serving in the neighborhood of 500,000 individuals. Dick Nelson offered prayer for Roger Oxendale and CMB.

30. REPORT FROM CENTRO HISPANO DE ESTUDIOS TEOLOGICOS

The moderator recognized Ed Delgado, president of CHET, who shared highlights, including three CHET graduates who are being ordained in 2018. Delgado also mentioned that Superintendent Danny Martinez of the Central Conference is a CHET graduate. Many countries are being served by CHET graduates. Valerie Thomas prayed for Ed Delgado and CHET.

32. REPORT FROM COVENANT TRUST COMPANY

The moderator recognized Ann Wiesbrock, president of Covenant Trust Company, who reported that CTC was created to serve the members, friends, and ministers of the Covenant Church. CTC has clients ranging from less than one year to 108 years old. It currently manages more than \$2 billion. CTC estate plans have distributed \$228 million to ministries in the Covenant. Meredith Randall prayed for Covenant Trust Company and Ann Wiesbrock.

18. MISSIONARY SERVICE RECOGNITION

The moderator recognized Al Tizon, executive minister of serve globally, and Gary Walter, president of the ECC, who honored the following three individuals for their missionary service: Keith and Florence Gustafson, Democratic Republic of the Congo (1984-2018) and Christy Taylor, East Asia (2007-2018).

COVENANT MISSION MOMENT 2

A "Celebrating the Mission" video was shown.

35. REPORT FROM PAUL CARLSON PARTNERSHIP

The moderator recognized Renee Hale, executive director of Paul Carlson Partnership, who gave her report. Hale outlined highlights of PCP's medical initiatives and economic development in DR Congo. Cindy Wu prayed for the PCP team and Renee Hale.

20. RECOGNITION OF EXECUTIVE BOARD MEMBERS CONCLUDING TERMS OF SERVICE

The moderator recognized Gary Walter, who expressed appreciation on behalf of the Evangelical Covenant Church to Rachel Burke, David Danielson, and Juana Nesta, for their service to the Executive Board.

38. APPROVAL OF MINUTES OF 133rd COVENANT ANNUAL MEETING

The moderator recognized Rebecca Gonzalez, who recommended that the minutes of the 133rd Annual Meeting of the Evangelical Covenant Church be reviewed and corrected by the officers of the Evangelical Covenant Church and approved by the Executive Board. The motion was seconded and carried.

36. MISSION AND MINISTRY LEADERSHIP RESPONSE TO DELEGATE QUESTIONS

The moderator recognized Nancy Lewis who invited administrators to come to the podium to answer delegate questions that had been presented in writing.

41. DELEGATE EVALUATION

The moderator recognized Rebecca Gonzalez, who invited delegates to fill out the emailed evaluation form.

39. ARRANGEMENTS FOR 2019 GATHER

Gonzalez reported that although they have been working on next year's Gather location, details are not yet finalized. The hope is to give details later this summer.

42. REPORT TO CONGREGATIONS

The moderator recognized Ed Gibreath, executive director of communication, who shared ways in which delegates could report back to their congregations: *Covenant Companion*, videos at Gather website, and delegate summary.

43. CLOSING STATEMENT

The moderator recognized Rebecca Gonzalez, who moved the following resolution of sympathy:
