Minutes of the 136th Annual Meeting of the Evangelical Covenant Church

Sheraton Kansas City Hotel at Crown Center Kansas City, Missouri June 23-25, 2022

FIRST BUSINESS SESSION Thursday, June 23, 2022 1:00 p.m.

1. CALL TO ORDER & MORNING WORSHIP

Moderator Elizabeth Jensen called the meeting to order at 1:00 p.m., beginning with a land acknowledgment read by Secretary Nilwona Nowlin. The land acknowledgment stated that the gathering takes place on the historical lands of the Kiikaapoi, Washtáge Mozha, Osage, and Ochethi Sakowin nations and peoples and expressed gratitude for the land and those who have stewarded it throughout many generations.

The moderator explained the logistics of this first-ever hybrid Annual Meeting: delegates are participating online and onsite in Kansas City, Missouri. Paul Robinson, executive minister of love mercy and do justice, provided the devotional.

3. GREETING FROM CHURCHES OF THE MIDWEST CONFERENCE

A video was shared with the assembly. It included a greeting from Tammy Swanson-Draheim, superintendent of the Midwest Conference, and an overview of ministry happening in the Midwest Conference.

2. OPENING STATEMENT BY THE MODERATOR

Moderator Elizabeth Jensen explained procedures, issued an opening statement, and introduced the officers on stage.

Erik Anderson, director of events, provided coaching on how delegates will be able to participate in this first-ever hybrid business meeting using the AGM Convene platform. After an instructional video, he facilitated a few rounds of practice voting. During this time, there were brief recesses to address Internet issues and prepare paper ballots for onsite delegates who continued to have difficulties connecting to the AGM Convene platform. To accommodate this, some agenda items will be moved to later business sessions.

Dominique Gilliard, director of racial righteousness and reconciliation, introduced a Sankofa video.

4. REPORT ON CREDENTIALS AND MOTION

The moderator recognized Tiana Coleman, chair of the credentials committee, who presented the following motion on behalf of the credentials committee: "Those persons who have currently been registered and certified as delegates with the committee on credentials together with those who shall subsequently be registered and certified in the course of this Annual Meeting shall constitute the official roster of the 136th Annual Meeting of the Evangelical Covenant Church."

The motion carried.

Coleman provided the following report:

Total credentialed voting delegates: 278 onsite, 212 online, for a total of 490

Total additional registrants in non-voting categories: 100 onsite, 8 online, for a total of 108 Total registered conference attendance of 378 onsite, 220 online, for a total of 598.

5. ACTION ON THE STANDING RULES

The moderator recognized Rick Lindholtz, vice-moderator, who, on behalf of the agenda committee and with the concurrence of the Executive Board, moved the adoption of the standing rules as modified with the addition of item 3d: Delegates onsite with connectivity issues will vote by paper ballot.

Proposed Standing Rules of Order for the 136th Covenant Annual Meeting

The Annual Meeting Agenda Committee recommends the adoption of the following proposed standing rules of order for the 136th Covenant Annual Meeting.

INTRODUCTION

The written documents that govern the Annual Meeting of the Evangelical Covenant Church are the Illinois Not For Profit Act, the Articles of Incorporation of the Evangelical Covenant Church, the Evangelical Covenant Church Constitution and Bylaws, the Rules for the Ordered Ministry of the Evangelical Covenant Church, the Covenant Pension Plan, and the most recent edition of Robert's Rules of Order (henceforth will be called Robert's Rules for purposes of this document). Robert's Rules provides that a convention or assembly of delegates such as the Covenant Annual Meeting may adopt its own standing rules to supplement the provisions of Robert's Rules and of its own documents. The Standing Rules provide guidance for this 136th Annual Meeting, setting out how items are dealt with generally. The Standing Rules require a two-thirds majority for adoption or suspension.

That the business of deliberative assemblies may be conducted by electronic means is given sanction in Robert's Rules most recent edition (the 12th ed., published in 2020, see Section 9, paragraphs 30-36). Procedures for establishing delegate credentials, obtaining the floor, discussion, and voting have been devised with due diligence to the spirit and letter of the Evangelical Covenant Church's governing documents, to Robert's Rules, and to the tradition of the Covenant Annual Meeting as a participatory and deliberative assembly.

STANDING RULES OF ORDER 2022 COVENANT ANNUAL MEETING

1. The Business Meeting Shall Be Conducted in Hybrid Format – both with Online and Onsite capabilities.

- a. All delegates, whether attending online or onsite, are expected to have reliable means for participation and are credentialed according to the principle of "one delegate, one login IP address."
- b. All delegates, whether attending online or onsite, are responsible for their own personal technological connectivity and tools; for elements related to engaging with the voting platform, delegates may pursue assistance with the vendor platform's tech support team; a delegate's personal technology failure does not constitute a point of order, of information, or of privilege to be addressed to the whole meeting.
- c. Quorum is determined by the ratio of the number of delegates attending online who are logged in plus the number of onsite delegates who are logged in to the number of registered delegates.
- d. All individuals called upon to present to the delegates on an agenda item must appear in person or via a prerecorded video.

2. Obtaining the Floor

a. Only those who have been credentialed as delegates, advisors, or resource persons can request the privilege to address the entire assembly, including on points of order, of information, and of personal privilege.

3. Voting

- a. All voting, whether delegates are attending online or onsite, is conducted electronically for this meeting, and meets the requirements stipulated in Robert's Rules for a secret ballot.
- b. All delegates will need a personal device (desktop, laptop, or mobile device) and an internet connection. For those attending onsite, an internet connection will be provided for you.
- c. Onsite or online delegates who are logged in but who do not vote on a question will be tallied as abstentions.

4. Debate

a. Recognizing that delegates will be engaging online and onsite, every effort will be made to ensure the experience is similar for a delegate regardless of the mode of participation. Within the limits of technology and/or delegate's connectivity, our hope is that no preference or priority will be given to either category of delegate. Customarily, Annual Meetings have attempted to organize debate alternating between speeches in favor and against, following the mic sequence. Seeking to uphold that custom while recognizing the differences in delegate participation, we will ensure online delegates have similar opportunities to engage as to onsite participants.

5. Time Limits

- a. Reports that contain no proposal for action by the meeting shall be limited to ten (10) minutes, including the question period, with the exception of the president's report, the treasurer's report, and items specified in the agenda to extend beyond the 10-minute time limit.
- b. Debate on any main motion, including its subsidiary motions, shall be limited to thirty (30) minutes, except as otherwise specified in these standing rules and the agenda. No amendment or other subsidiary motion to a main motion shall be allowed until debate on the main motion has ceased or ten (10) minutes have passed.
- c. No speech in debate may exceed three (3) minutes unless this period is extended by a majority vote at the request of the speaker.
- d. Time limits may be extended for a specific period by a two-thirds vote.
- e. Unless otherwise indicated on the schedule as a lunch or dinner break, any breaks called by the Moderator will be thirty (30) minutes long.

6. Action on Involuntary Removals

Credentialed ministers have the right to object to his or her removal of credentials as recommended by the Board of Ordered Ministry and approved by the Covenant Ministerium as provided in Section 10.3.e. of the Rules of the Ordered Ministry. At this Annual Meeting, this matter may come before us for action. To address these matters in a fair and sensitive fashion, the Annual Meeting will proceed as follows:

- a. A credentialed minister objecting to his/her removal of credentials from the ordered ministry shall have up to ten (10) minutes to speak on why he or she should not have their credentials removed. The Board of the Ordered Ministry shall have up to ten (10) minutes to respond through its designated representatives.
- b. As these matters pertain to membership, it is appropriate for these matters to be taken up in Executive Session upon the appropriate motion to that effect. Only delegates and approved resource personnel may witness and participate in Executive Session.
- c. On each of these actions, debate that follows the presentations shall proceed according to these Standing Rules, Section 4) Debate, and Section 5) Time Limits b), c), d).

7. Submission of Motions in Writing

All main motions and subsidiary motions shall be submitted electronically via the voting platform

using the "Type a Question" feature and addressing the Annual Meeting secretary or via email (governance@covchurch.org) and addressing the Annual Meeting secretary.

8. Items of Business Not on the Agenda

The Bylaws provide in Section 7.8.a.ii that "Items of business that are not on the agenda may be submitted in writing by a delegate to the moderator. If the item submitted is in order, a majority vote of the delegates present and voting shall be required to place that item on the agenda." It is further strongly requested that such items be submitted electronically by delegates to the moderator at governance@covchurch.org prior to the start of the 136th Covenant Annual Meeting.

9. Consent Agenda

Items on the Consent Agenda are routine, procedural, informational, self-explanatory non-controversial items that require action but generally do not require discussion or debate. Acting on these items moves the meeting along, allowing for more time for substantive issues.

- a. Items on the Consent Agenda may be removed from the Consent Agenda at the request of any two delegates.
- b. Items removed from the Consent Agenda shall be acted upon by the assembly at a place in the agenda determined by the moderator.
- c. If the Consent Agenda is not adopted as a single motion, then each of the items on the Consent Agenda shall be acted upon by the assembly as a separate motion at a place in the agenda determined by the moderator.

10. Contested Election Procedures for President and Executive Ministers

- a. *Nominations from the Floor*. A nomination from the floor shall be accepted only if the person nominated has agreed to have his or her name placed in nomination.
- b. Delegates desiring to make nominations for a second candidate shall electronically submit to the moderator via the voting platform using the "Type a Question" feature or via email (governance@covchurch.org), the nominator's name, the church or entity the nominator represents, the name of the potential candidate with an affirmation that the potential candidate satisfies the particular requirements of the office as provided in the Constitution and Bylaws, and descriptive information regarding the potential candidate similar in scope and content to that provided to the Annual Meeting by a nominating board or committee.
- c. If a second candidate is nominated and immediately following the close of nominations, the moderator will provide a sixty (60) minute recess for a candidate forum during which each candidate will have five (5) minutes to make an opening statement. Thereafter for thirty (30) minutes, each candidate will respond to questions relating to their vision for the future of our denomination. For the remaining twenty (20) minutes candidates will answer questions submitted electronically from delegates via the voting platform using the "Type a Question" feature or via email (governance@covchurch.org). Parliamentarian Eric Filkin will moderate the candidate forum.
- d. Following the candidate forum, a motion will be heard to add the second candidate to the ballot. If more than one candidate is nominated from the floor, delegates will determine by ballot which candidate will be added as the second candidate to the ballot. Once the ballot has been approved, delegates will vote.

11. Runoff Elections

In the case of an election with three or more candidates, if no candidate receives a majority of votes after two rounds of voting, then beginning with the third round, the candidate with the lowest number of votes in that round will be eliminated. In the event of a tie among the lowest vote-getters, those tied will not be eliminated in that round. A candidate may withdraw at any point. Voting rounds will continue until one candidate receives a majority of votes.

12. Modification of Agenda Order

The moderator shall have the discretion to revise the order of agenda items to accommodate scheduling needs.

The moderator recognized Rebecca Gonzalez, executive director of operations, who reported that the Executive Board recommended the adoption of the agenda as follows with modified time certains. Updated times will be provided during the Friday morning session for the following items: Service Recognition for Global Personnel, and Fiscal Year 2020/21 Performance Report. The Irving Lambert Outstanding Urban Ministries Award will be presented after the T.W. Anderson Outstanding Layperson Award. The 10:30 a.m. Saturday time certain, Removal of Ministerial Credentials, was contingent upon action by the Covenant Ministerium. The Ministerium did not move the item forward to the Annual Meeting, so this time certain is being removed from the agenda. Gonzalez encouraged delegates to remain fully engaged in all sessions to ensure that quorum is maintained.

Per approval of the Annual Meeting Officers, Annual Meeting planning committee, and Covenant Executive Board, the following agenda items are being amended: Agenda item 21.a.7.ii is being redacted; as previously mentioned, this item was contingent upon action by the Ministerium, and the Ministerium did not move the item forward to the Annual Meeting. Agenda item 19 is being amended to include the call of the Dean of the Seminary.

Delegate Frank Riley moved to add to the agenda the following item: "That our newly elected president return to the 2023 Annual Meeting with a report and recommendations for definitive and concrete actions to bring our divide on human sexuality to resolution, engaging appropriate governance bodies in doing so." Motion was seconded.

After a time of discussion, delegate Liz VerHage moved to amend the proposed item. However, the moderator declared this motion out of order because the item must be approved as an agenda item before it can be amended. After further discussion, delegate Julia Stein Sandstrom called the question. The assembly voted to end the debate.

The initial motion to add an agenda item carried. This item will be addressed during the Saturday morning business session at 10:30 a.m.

Delegate Rich Theilen moved to retain item 21.a.7.ii, but it was declared out of order because the 30-minute time limit for debate has ended. Delegate Andy League moved to extend the debate for 15 minutes. Motion was seconded, and it failed.

The motion to adopt the modified agenda carried.

The motion carried. There were no honorary delegates.

8. CHURCHES APPLYING FOR MEMBERSHIP IN THE EVANGELICAL COVENANT CHURCH

The moderator recognized Paul Lessard, executive minister of start and strengthen churches, to present the churches applying for membership. Churches were presented by conference superintendents and staff. Lessard, upon the recommendation of the respective conferences and regions, and on behalf of the Executive Board, moved that the 136th Annual Meeting accept the following churches into membership in the Evangelical Covenant Church:

The motion was approved, the churches were accepted into the membership of the Evangelical Covenant Church, and the moderator declared them all to be full members. Mary Hendrickson, director of missional vitality, prayed for the new Covenant congregations.

15. ELECTION OF PRESIDENT OF THE EVANGELICAL COVENANT CHURCH

The moderator recognized Steve Dawson, chair of the presidential nominating committee, who on behalf of the committee presented Tammy Swanson-Draheim as the nominee for the eleventh president of the Evangelical Covenant Church. This is an historic moment because Swanson-Draheim is the first woman nominated for the role of president.

The moderator opened the floor for nominations. No additional candidates were nominated, and the nominations were closed.

The election followed. Swanson-Draheim was elected by a vote of 541 "for" (95 percent), 26 "against" (4 percent), for a total of 567 votes.

The moderator recognized Swanson-Draheim, Juana Nesta, Evelyn Johnson, and Catherine Gilliard. Johnson and Gilliard offered words of encouragement to president-elect Swanson-Draheim in honor of this historic moment, and Nesta prayed for her.

Tammy Swanson-Draheim briefly addressed the delegates.

16. ELECTION OF EXECUTIVE MINISTER OF DEVELOP LEADERS AND THE ORDERED MINISTRY

The moderator recognized Sharon Anderson, chair of the ordered ministry and develop Leaders nominating committee, who on behalf of the board and in concurrence with the Ministerium, presented Herb Frost as the nominee for executive minister of develop leaders and the ordered ministry.

The moderator opened the floor for nominations. There were none, and the nominations were closed.

The election followed. Frost was elected by a vote of 496 "for" (91 percent) and 47 "against" (8 percent) for a total of 543 votes.

Frost briefly addressed the delegates, and Anderson prayed for him.

17. ELECTION OF EXECUTIVE MINISTER OF SERVE GLOBALLY

The moderator recognized Cindy Wu, chair of the executive minister of serve globally nominating committee, who on behalf of the committee, presented Grace Shim as the nominee for executive minister of serve globally. This is a historic moment because Shim is the first female and active global personnel nominated for the role of executive minister of serve globally.

The moderator opened the floor for nominations. There were none, and the nominations were closed.

The election followed. Shim was elected by a vote of 507 "for" (99 percent) and 5 "against" (0.9 percent) for a total of 512 votes.

Shim briefly addressed the delegates, and Wu prayed for her.

19. CALL OF DEAN OF NORTH PARK THEOLOGICAL SEMINARY

The moderator recognized Mary Surridge, president of North Park University and member of the North Park University and North Park Theological Seminary nominating committee for the dean of the seminary, who on behalf of the committee and in concurrence with the Ministerium, presented Rev. Dr. Dennis Edwards as the nominee for dean of the seminary and vice-president of church relations for North Park University. This is a historic moment because Edwards is the first African American nominated for the role of dean of the seminary and vice-president of church relations for North Park University.

The election followed. Edwards was elected by a vote of 499 "for" (99 percent) and 3 "against" (0.5 percent) for a total of 502 votes.

Edwards briefly addressed the delegates, and Dave Kersten, dean of the seminary and vice-president of church relations for North Park University, prayed for him.

The moderator recognized Erik Anderson for closing announcements before recess. The moderator recognized Rick Lindholtz, vice-moderator, who gave final comments. The assembly recessed at 6:39 p.m.

SECOND BUSINESS SESSION

Friday, June 24, 2022 8:30 a.m.

1. MORNING WORSHIP CONTINUED

Moderator Jensen called the business session to order at 8:30 a.m. (CDT). The moderator recognized Becky Ykema, worship leader, and the speakers for the morning: Greg Yee, superintendent of the Pacific Northwest Conference; Chris Ek, pastor of Bethany Covenant Church; and T.J. Smith, president of the Indigenous Ministers Association.

The moderator recognized Erik Anderson to facilitate a live demo of the AGM Convene platform and provide further instructions for using the platform as well as the wifi network.

36. MISSION AND MINISTRY LEADERSHIP REPORT

The moderator recognized vice-moderator, Rick Lindholtz, who called the delegates' attention to the annual report provided online and in the delegate resource box. He invited delegates to submit any questions they might have of administrators by 4:30 p.m. on Friday for responses from administrators during a Saturday business session. Lindholtz reminded delegates that questions can be submitted via email or the "Ask a Question" feature on the AGM Convene platform.

4b. CREDENTIALING REPORT #2

The moderator recognized Sandy Norris, member of the credentialing committee, for the third report.

Total credentialed voting delegates: 239 onsite, 278 online, for a total of 517.

Total additional registrants in non-voting categories: 100 onsite, 18 online, for a total of 118.

Total registered conference attendance of 339 onsite, 296 online, for a total of 635.

MISSION MOMENT – START AND STRENGTHEN CHURCHES

Prior to the commissioning of church planters, a video shared the story of how one church plant was able to overcome obstacles and experience growth during the early days of the COVID-19 pandemic.

9. CHURCH PLANTER COMMISSIONING

The moderator recognized Paul Lessard, executive minister of start and strengthen churches; Alex Rahill, director of church planting; Fil Nesta, director of church planter assessment center; and Mike Brown, director of church planter training. Lessard introduced two new church planters who signed church planter agreements: Valerie Grimes (Radiant Church, Savannah, Georgia) and Eneas Barbarosa (Brazilian Covenant Church, Huntington Beach, California).

Nesta prayed for these two new church planters. Lessard then recognized all church plants that have been commissioned since the last Annual Meeting.

Rahill acknowledged church planter Diamond DeYampert of The Freedom Room: An Evangelical Covenant Church (Detroit, MI), who died unexpectedly earlier in the month. Rahill led a time of prayer for all these church planters and their congregations.

38. REPORT FROM COVENANT MINISTRIES OF BENEVOLENCE

The moderator recognized Todd Slechta, president of Covenant Ministries of Benevolence, who introduced Scott Hanson to provide a report on the Swedish Covenant Hospital sale proceeds. Hanson explained that this report was requested by the 2021 Annual Meeting delegates.

Terri Cunliffe, CEO of Covenant Living Communities and Services, presented ministry highlights of the past year.

18. CALL OF PRESIDENT OF COVENANT MINISTRIES OF BENEVOLENCE

The moderator recognized Sue Poston, chair of the Board of Benevolence and member of the Executive Board, who on behalf of the Board of Benevolence and with the concurrence of the Executive Board of the Evangelical Covenant Church, presented Todd Slechta as the nominee for president of Covenant Ministries of Benevolence. Slechta has served as the acting president for the past 18 months.

The election followed. Slechta was elected by a vote of 564 "for" (99 percent) and 3 "against" (0.5 percent) for a total of 567 votes.

Slechta briefly addressed the delegates, and Poston prayed for him.

MISSION MOMENT – ANTIRACISM DISCIPLESHIP PATHWAY

The moderator recognized Dominique Gilliard, director of racial righteousness and reconciliation, to present a mission moment on behalf of Love Mercy and Do Justice. Gilliard provided an update on the creation of a new discipleship resource for Covenant leaders, the Antiracism Discipleship Pathways. They prioritize loving neighbors by learning their stories and lived experiences. Over the first two years, more than 450 Covenant leaders have been served through the pathways. Gilliard shared testimonies from pathway participants and invited Covenant ministers to sign up for future pathways.

41. REPORT FROM NORTH PARK UNIVERSITY

The moderator recognized Mary Surridge, president of North Park University, who presented a report on North Park's ministry, including the celebration of North Park's 130th anniversary.

41b. REPORT FROM NORTH PARK THEOLOGICAL SEMINARY

The moderator recognized Dave Kersten, dean of North Park Theological Seminary and North Park University's vice president for church relations, who is also serving as interim executive minister of develop leaders and the ordered ministry. Kersten provided a report on the seminary's ministry. Highlights included the calling of Rev. Dr. Dennis Edwards as the dean of the seminary, one of the largest graduating classes (84 graduates), and the historic commencement of the first cohort of Masters in Arts in Restorative Justice students from Stateville Correctional Center. The commencement speaker for the graduation ceremony at Stateville was Kim Foxx, Cook County State's Attorney.

Greg Jao, member of the Executive Board, prayed for Surridge and Kersten and the ministries and communities they lead.

19. CALL OF NORTH PARK THEOLOGICAL SEMINARY FACULTY MEMBERS AND DEAN OF THE SEMINARY

The moderator recognized Dave Kersten who called Rev. Dr. John Nathan Clayton to the stage. On behalf of the Board of Trustees of North Park University with the concurrence of the Board of the Ordered Ministry, the Ministerium, and the Executive Board of the Covenant, Kersten presented Rev. Dr. John Nathan Clayton to serve as a faculty member of North Park Theological Seminary.

The election followed. Clayton was elected by a vote of 529 "for" (98 percent) and 9 "against" (0.1 percent) for a total of 538 votes.

Clayton briefly addressed the delegates, and Kersten prayed for him.

29. RECOGNITION OF DAVE KERSTEN, DEAN OF NORTH PARK THEOLOGICAL SEMINARY

The moderator recognized John Wenrich, Mary Surridge, and Howard Burgoyne, superintendent of the East Coast Conference and member of the Executive Board. After a video overview of Kersten's ministry, Surridge shared that Kersten was the recipient of the David Nyvall Medallion, which was presented at the May 2022 commencement ceremony. Wenrich and Surridge shared remarks, and Wenrich presented Kersten with a citation and gift. Kersten briefly addressed the delegates, and Burgoyne prayed for him.

32. FINANCIAL REPORT

Fiscal Year 2020/21 Performance Report

The moderator recognized Steve Klimkowski, chief financial officer and treasurer of the Covenant, who presented a financial report for fiscal year 2021. The FY2021 financial performance was \$73,339 better than budget. Klimkowski also presented a video overview of Covenant Benefits (formerly "Bethany Benefit Service"). In 2023, two new medical plans will be available, a gold plan option and a high-deductible silver plan option. Both 2020 and 2021 audits are being reported to the 136th Annual Meeting.

34. REPORT FROM THE COVENANT BOARD OF PENSIONS AND BENEFITS

During the financial report, Klimkowski provided an update from the Covenant Board of Pensions and Benefits.

The moderator recognized Scott Dennis, who led a prayer of thanksgiving for God's faithfulness and the generosity of Covenant churches and donors who gave sacrificially during the pandemic.

MISSION MOMENT – COVENANT KIDS CONGO 10-YEAR CELEBRATION

After a video celebrating the 10th anniversary of Covenant Kids Congo, the moderator recognized Lyndsey Watson, Covenant Kids Congo ministry specialist, who thanked Covenanters for their support.

39. REPORT FROM COVENANT TRUST COMPANY

The moderator recognized Ann Wiesbrock, president of Covenant Trust Company, who presented a report on the ministry of CTC.

The vice-moderator gave updates on the afternoon schedule and reminded delegates to submit questions for leaders before 4:30 p.m. (CDT). He also gave instructions for lunch. The assembly recessed at 11:57 a.m.

Wenrich encouraged the assembly with these words: The Church was built for a time like this. He urged us to never stop serving, never stop praying, never stop sharing the good news of Jesus with the world so that everyone has the opportunity to meet, know, and follow Jesus. This is the heart of the Covenant.

Wenrich concluded his report with a time of blessing. The moderator recognized Evelyn Perez, Covenant Executive Board member, who prayed for Wenrich.

33. PRESENTATION AND ADOPTION OF THE 2023 MISSION AND MINISTRY BUDGET

The moderator recognized Steve Klimkowski, chief financial officer and treasurer of the Covenant, who gave a presentation on the mission and ministry budget for fiscal year 2023 and a proposed mission and ministry budget of \$18,289,248.

Klimkowski presented the following motion: "The Finance Committee, the Covenant Council of Administrators, and the Executive Board recommend the fiscal year 2023 Mission and Ministry Budget in the amount of \$18,289,248 for adoption by the 2022 Covenant Annual Meeting." The mission and ministry expense budget is as follows:

After a time of discussion, the motion carried.

The moderator recognized Karen Stein, chair of the finance committee of the Covenant Executive Board, who prayed for Klimkowski and the 2023 Mission and Ministry operating budget.

53. RECOMMENDATION TO THE PRESIDENT'S OFFICE REGARDING HUMAN SEXUALITY AND UNITY

The moderator recognized vice-moderator, Rick Lindholtz, who read aloud the agenda item proposed by Delegate Frank Riley: "That our newly elected president return to the 2023 Annual

Meeting with a report and recommendations for definitive and concrete actions to bring our divide on human sexuality to resolution, engaging appropriate governance bodies in doing so."

Delegate Peter Frost moved to amend the original motion to read: "Recommend that our newly elected president return to the 2023 Annual Meeting with a report on the work being done to address our divide on human sexuality, and provide a clear update on the direction and progress that is being made for our path forward as a denomination." The moderator ruled this motion out of order because the original debate had not gone on for 10 minutes. After reaching the 10-minute threshold Frost presented the motion again. The motion was seconded, and a discussion followed.

After 28 minutes of discussion, delegate Julia Sandstrom motioned to extend the debate for 15 minutes. After being seconded, the motion failed.

The amendment to the original motion carried. The amended motion carried. The moderator recognized vice-moderator, Rick Lindholtz, who prayed.

MISSION MOMENT – START AND STRENGTHEN CHURCHES

The moderator recognized Mary Hendrickson, director of missional vitality. After a video, Hendrickson shared about missional vitality resources that are available to congregations, such as the pH (periodic health) check assessment and "Finding Your Why" workshop.

13. UPDATE ON FREEDOM, UNITY, AND RESPONSIBILITY RESOURCE PAPER

The moderator recognized Howard Burgoyne, superintendent of the East Coast Conference and chair of the Freedom, Unity, and Responsibility resource paper writing team. Burgoyne provided an update on the continued work of the resource paper writing team. The team consists of: Burgoyne, Dr. Hauna Ondrey, Rev. Dr. Stephen Bilynskyj, Rev. Nilwona Nowlin, Rev. Dr. Donn Engebretson, Rev. Angela Yee, and Rev. Dr. John Wenrich. (Prior to resigning as executive minister of Develop Leaders and the ordered ministry, Rev. Lance Davis was also on the team.) The primary writers are Burgoyne and Ondrey. A draft of the paper will soon be translated into Spanish and distributed to readers for feedback. The team expects to bring forth a draft to the Annual Meeting in 2023.

The assembly recessed at 12:06 p.m.

The motion to remove the churches from the roster carried. The moderator recognized Paul Lessard, executive minister of Start and Strengthen Churches, who prayed for the churches, communities, and congregants navigating these transitions.

14. REPORT AND ACTION ON THE COVENANT CONSTITUTION AND BYLAW AMENDMENTS

The moderator recognized Rebecca Gonzalez who presented updates and items for approval.

The following item, Report on North Park University Bylaw Amendments, has been approved by the Annual Meeting Officers and the Covenant Executive Board. The approved language is included below:

Section 12.3. North Park University.

b. The Board of Trustees shall consist of twenty-five to no more than thirty members, comprised of elected members, appointed members, and ex-officio members. Each member of the Board of Trustees shall be a member in good standing of a member congregation of the ECC or another Christian church as

further set below. Each member of the Board of Trustees serves all ECC congregations.

i. Elected Members.

- (1) Candidates for the Board of Trustees to be elected by the Annual Meeting shall be slated according to the procedures of the Board of Nominations and elected by the Annual Meeting. The Board of Trustees may recommend candidates to the Board of Nominations.
- (2) At least three elected members shall meet the criteria of the ECC policy on ethnic representation.
- (3) At least 20 percent of the elected members shall be clergy and at least 20 percent shall be lay.
- (4) At least 35 percent of the elected members shall be female. At least 35 percent of the elected members shall be male.
- (5) Each elected member shall be a member in good standing of a member congregation of the ECC.
- (6) An elected member may be elected up to four consecutive threeyear terms

ii. Appointed Members. Up to nine persons shall be recommended by the Board of Trustees and appointed by the Executive Board for up to four terms of three years. Each appointed member shall be a member in good standing of a Christian church and shall be in harmony with the mission of North Park University. Appointed members are not required to be members of ECC congregations. An appointed member may be suspended or removed for cause only if such action is recommended by a two-thirds (2/3) vote of the other members of the Board of Trustees and approved by a three-fourths (3/4) vote of all the members of the Executive Board. Cause for suspension or removal is failure to perform duties, malfeasance, misfeasance, immorality, indiscretion, unethical behavior, doctrinal error, breach of fiduciary duty owed to the ECC, breach of a duty of confidentiality owed to the ECC, or breach of a duty of loyalty owed to the ECC.

The following items were introduced to the 135th Annual Meeting of the Covenant with action to be taken by the 136th Annual Meeting:

Action on the Proposed 2021/2022 Constitutional Amendments

<u>Section 1.1.</u> The name of this body shall be The Evangelical Covenant Church (the "Covenant" or the "ECC").

<u>Rationale:</u> Move to remove the acronym (ECC) throughout the document and instead utilize "Covenant" throughout our formal communication. We are moving toward standardizing the use of our name, Evangelical Covenant Church, Covenant, or the Evangelical Covenant Church throughout our communication resources.

<u>Section 7.4.</u> Each <u>"ECC"</u> Covenant congregation, each regional conference, and each <u>"ECC" world mission</u> Covenant global mission region is entitled to send one or more delegates to the Annual Meeting, as provided in the Bylaws. The Bylaws may provide for

additional delegates and advisors. Each delegate shall serve for a term that expires at the convening of the next Annual Meeting as provided in the Bylaws. Each delegate shall be a corporate member of the ""ECC"" Covenant for the duration of that delegate's term.

Rationale: Move to replace the word "world" with "global."

Section 16.2. At least ninety days before the Annual Meeting when final action is to be taken on a proposed amendment to the Constitution, the corporate secretary of the "ECC" Covenant shall send a copy of each proposed amendment to each "ECC" Covenant congregation and shall cause the text of each proposed amendment to be published in the official print publication communication channels of the "ECC" Covenant and in the electronic media that the "ECC" Covenant regularly uses for communication with "ECC" Covenant congregations and members of "ECC" Covenant congregations.

<u>Rationale:</u> Move to replace the word "print publication of the 'ECC'" with "communication channels of the Covenant" to capture our growing reliance on electronic media.

The motion carried.

Presentation on 2022 Covenant Bylaws Amendments

Section 7.2. The Executive Board shall designate the time, **place, and medium** of each Annual Meeting.

<u>Rationale</u>: After the pandemic, and with the growing fiscal/social demands evolving in our society, this modification allows for the Covenant Executive Board to define the means for Annual Meeting engagements. They presently select the place and time. This increases the flexibility to elect in-person, virtual, or hybrid modes of engagements. The director of events, the president of the Covenant, and the Council of Administrators will continue to serve as advisors in this decision-making process.

Section 7.8.a.iii. Copies of the proposed agenda and accompanying materials shall be available to delegates electronically or in writing **sixty days** thirty days prior to the meeting.

<u>Rationale:</u> This modification aligns the timeline of notification with the expectation stipulated in Article XVI. Section 16.2 and ensures delegates and their respective congregations receive Annual Meeting material in a timely manner, regardless of the meeting's setting or medium.

Section 7.9. Elections and Calls.

a. ECC President.

ii. One candidate for president of the ECC shall be nominated by a Presidential Nominating Committee consisting of the following: twelve persons elected by the Executive Board from its elected members so as to reflect the composition of the Executive Board as a whole; one person each elected by and from the elected members of the Board of Directors of Covenant Ministries of Benevolence, the Board of the Ordered Ministry, the Board of Pensions and Benefits, and the Board of Trustees of North Park University;, and the chairs of one member of each of the Executive Boards of the Regional Conferences. The Presidential Nominating Committee

shall have at least one member from every ethnic group that has an established ethnic association within the Covenant.

<u>Rationale</u>: With input from the Presidential Nominating Committee (PNC), the Covenant Executive Board sought to provide greater flexibility on the representatives from the conferences' Executive Boards, while also continuing to advance the multiethnic mosaic of which we are all a part. A member from a Conference Executive Board may be elected by their peers to represent the conference on the PNC. The PNC membership will have a minimum of one member from the Covenant Ethnic Associations. This modifies representation on the PNC, not the total number of members on the PNC.

Section 8.2. Composition and Selection of the Executive Board.

b. *Ex-officio Members*. The Executive Board shall have the following ex-officio members: the president of the ECC, a conference superintendent designated by the Council of Superintendents who serves as liaison from that council, an elected member of the Board of Directors of Covenant Ministries of Benevolence, and Centro Hispano de Estudios Teológicos del Pacto Evangélico, and an elected member of the Board of Trustees of North Park University who serves as a liaison from these boards to the Executive Board. An ex-officio member of the Executive Board who serves as a liaison from another board shall not be an employee of the ECC, any ECC institution, any regional conference, any conference institution, or any regional mission organization.

<u>Rationale</u>: This aligns the bylaws to the collaborative efforts that have been happening since 2016 when CHET transitioned under the umbrella of Covenant Organizations.

A delegate motioned that the items be voted on separately. After a second, the assembly voted. The motion failed. The motion to approve the amendments as listed carried.

The following item is being introduced to the 136th Annual Meeting of the Covenant with action to be taken by the 137th Annual Meeting:

Report and Action on 2022/23 Covenant Constitutional Amendments

Section 7.4. Each ECC congregation, each regional conference, and each ECC world mission **serve globally** region is entitled to send one or more delegates to the Annual Meeting, as provided in the Bylaws. The Bylaws may provide for additional delegates and advisors. Each delegate shall serve for a term that expires at the convening of the next Annual Meeting as provided in the Bylaws. Each delegate shall be a corporate member of the ECC for the duration of that delegate's term.

<u>Rationale</u>: This is a minor cleanup from when we modified our language in 2014 from "world mission" to "serve globally." This edit brings the sentence into alignment with our mission priority language and its usage throughout the governance documents.

MISSION MOMENT – CRESCENDO

The moderator recognized Tim Ciccone, director of youth ministry. After a video, Ciccone introduced Pastor Steve Wong who gave a good news report on the ministry being done through Crescendo and efforts to better address concerns of mosaic churches. Crescendo is working with the Marketing and Communications team to capture legacy stories from Latino, African American, and Indigenous Covenanters.

43. MISSION AND MINISTRY LEADERSHIP RESPONSE TO DELEGATE QUESTIONS

The moderator recognized vice moderator, Rick Lindholtz, who invited the following leaders on stage to respond to delegate questions that had been presented in writing: Erik Anderson, Dave Kersten, Sharon Anderson, Mary Surridge, and Tammy Swanson-Draheim. Parliamentarian, Eric Filkin, also responded to questions.

12. REPORT ON STRATEGIC ALIGNMENT TEAM RECOMMENDATION

The moderator recognized Rebecca Gonzalez, who provided a brief report on the Strategic Alignment Team recommendation. Last October, the Covenant Executive Board, with the concurrence of the Covenant Offices Leadership Team, voted to rescind all recommendations of the Strategic Alignment Team to allow president-elect Tammy Swanson-Draheim to have a voice in strategic planning.

24. RECOGNITION OF JOHN WENRICH, PRESIDENT OF THE EVANGELICAL COVENANT CHURCH

The moderator recognized John Wenrich and Covenant Executive Board officers Jon Bonkoski (chair), Valerie Weyand (secretary), and Cindy Wu (vice-secretary). They presented President Wenrich with a citation and gift. After a video presentation, Wenrich addressed the delegates, and Weyand prayed for Wenrich and his family.

26. RECOGNITION OF EXECUTIVE BOARD MEMBERS CONCLUDING TERM OF SERVICE

The moderator recognized John Wenrich and Rebecca Gonzalez. Gonzalez expressed appreciation on behalf of the Evangelical Covenant Church to Roberto Ghione, Dwain Tissell, and Cindy Wu for their service to the Executive Board and presented them with gifts on behalf of the Executive Board. Evelyn Perez, Erick Marquez, Doris Granberry, and David Holder were honored in their absence. Wenrich prayed a prayer of thanksgiving for the board members.

25. RECOGNITION OF REBECCA GONZALEZ, EXECUTIVE DIRECTOR OF OPERATIONS

The moderator recognized John Wenrich, who presented Gonzalez with a citation and gift. After a video presentation, Gonzalez addressed the delegates, and John Bonkoski prayed for her.

The moderator recognized Rebecca Gonzalez, who moved the following resolution of sympathy:
